YARA - ELLARIA SEPARATION MEDIATION

- 1 A. Valhalla is an age old country with a rich mythological foundation. Valhalla's mythology
- 2 believed in personal freedom and had considerable recognition to same gender relationship.
- 3 However, in 1600, the Kingdom of Westeros invaded Valhalla and made it its colony.
- 4 Kingdom of Westeros introduced its laws in Valhalla which included criminalisation of
- 5 physical relationship between two adults of same gender.
- 6 **B.** After a long fight for independence, Valhalla was finally independent in 1975 as a
- 7 parliamentary democratic republic. Valhalla was very much inspired by India and its
- 8 democratic structure and legal jurisprudence.
- 9 C. Yara Greyjoy and Ellaria Sand were schoolmates. Ellaria was believed to be a gifted artist
- while Yara was praised for her hardworking and dedication. Moreover, both were regarded
- as having progressive and modern mindset. Both were close to each other since childhood.
- 12 Afterwards, Ellaria chose to pursue a career in fashion designing while Yara decided to
- pursue law.
- 14 **D.** On 06th September 2018, the Indian Supreme Court declared the law criminalising physical
- 15 relationship between adults of same gender as unconstitutional. Motivated by this, Yara
- moved a petition before the Apex Court of Valhalla and in December 2018, the Apex Court
- of Valhalla also declared the colonial aged law as unconstitutional.
- 18 E. Soon, thereafter, Ellaria addressed the national media and declared Yara and herself to be
- 19 couples. A mansion was purchased and was named Winterfell, and both started living
- 20 together. At this time, Yara adopted a girl and named her Nymeria. Ellaria, being talented
- 21 and gifted, started receiving offers from around the world for fashion designing while Yara's
- 22 practice took a hit after the declaration made by Ellaria. In the end of March 2019, Ellaria
- 23 received an offer in Paris, France and as a result she moved there and obtained French
- 24 citizenship. Yara used to frequently visit her in France and both enjoyed touring around the
- 25 city. Considering France had better schooling, Yara agreed to send Nymeria to Paris for her
- schooling and since April 2019 she too shifted to Paris to stay with Ellaria and Nymeria.
- 27 F. In June 2019, Yara came across a well-known political leader, Ragnar Lothbrok. As they
- 28 started spending more time together, they became quite close. Both were frequently posting
- 29 their pictures on social media which made Ellaira uncomfortable. As a surprise to her,
- Ragnar and Yara announced their plans to get married on 15th July 2019. Agonised by this
- 31 news, Ellaria sent a legal notice to Yara against going ahead with the marriage without
- 32 annulling their relationship. Yara, categorically denied coming under any matrimonial

- 33 relationship with Ellaria. Further, Yara also asked Nymeria to return to Valhalla which
- 34 Ellaria refused. Ellaria instead asked Yara to vacate Winterfell.
- 35 G. The above news broke into media and started gaining enough attention. Ragnar asked Yara
- 36 to settle the dispute as it was hurting his reputation as a politician. Further, Ellaria was also
- 37 made subject to questioning by the national media of Valhalla which she was trying to avoid.
- As a result, both Yara and Ellaria agreed to mediate their dispute on following issues:
- 39 i. Whether Yara and Ellaria were in a matrimonial relationship?
- 40 ii. Who should have the custody of Nymeria and possession of Winterfell?
- 41 H. Both the parties agreed to have their counsels represent their case and to mediate on their
- 42 behalf before the Mediators.
