#### **Submission- Details and Guidelines**

- ❖ Abstracts of not more than 300 words, for original research papers on the above mentioned themes are invited, submitted as Word document, with a brief bio of 200 words along with one photograph.
- ❖ The full length research paper should be within 5000 words (including footnotes).
- ❖ Potential contributors are required to adhere to a uniform mode of citation (20<sup>th</sup> edition of The Bluebook: A Uniform System of Citation is recommended).
- ❖ All abstracts/papers must be written in Times New Roman with font size 12.

#### **Publication**

Full papers will be published, after peer-review in special issue edition of the 'NUJS Journal of Regulatory Studies' with ISSN: 2456-4605 (O). A few cutting edge research papers will also be published in a conference proceeding book published by Taylor and Francis.
