ABOUT THE EVENT

It gives us immense pleasure to apprise you that the Society for Constitutional Law & Human Rights (SCLHR), established under the aegis of the School of Law, UPES is celebrating 75years of the Indian Constitution. In furtherance to this, we are pleased to announce the fifth edition of "You, Amend Your Constitution!" The objective of this event is to provide an opportunity for the students to propose amendments to the constitution based on their rational thoughts and to defend it with their analogy and reasoning. The competition is divided into two segments, the first being the written submission followed by oral arguments.



ROUND 1

The first round of the competition involves the written submission. The participants will be required to submit a written draft about the amendments they propose. A panel of Academicians will review the submissions and may select or reject them based on the choice of amendment selection, its contemporary relevancy, the arguments and reasoning, knowledge of the law, and conclusive remarks.









SUBMISSION GUIDELINES

- •The submissions must be original work.
- ·Submissions should be within the limit of 2500 words.
- ·All the relevant sources must be duly acknowledged in footnotes or endnotes conforming to the Bluebook 20th Edition.
- Submissions should be in Times New Roman, size 12, justified alignment, and 1.5 line spacing of an A4 sheet.
- Submissions shall not contain the names of the participants. The name of the participants should be provided in a separate cover letter. (A Google Link will be provided to all participants to upload the written submissions via email).
- ·Submissions with plagiarism of more than 20% will be rejected.
- ·Submissions must be in a doc or .docx (MS Word) file type.

FORMAT OF THE WRITTEN SUBMISSION

- 1. Title
- 2. Introduction
- 3. Identification of the Chapter/Part/Article/Schedule you want to amend, repeal, remove, revise, modify, add.
- 4. Arguments and reasoning behind the changes made
- 5. Conclusion
- * Note: the students would have the discretion to include additional sections in the paper. But the above format would be mandatory to follow.

ROUND 2

Based on the marks obtained in the first round, 15 written drafts will be selected for the second round which is the oral round. The oral rounds would be hosted offline at UPES. Each participant will be given 15 minutes, out of which 8 minutes will be allotted for the opening statement by the participant, and the remaining 7 minutes are saved for a question-answer round by a panel of external judges. The participants will be judged on how comprehensively they bring out their analogy for the amendment proposed and based on their answers to the questions raised by the judges.

WHO ALL CAN PARTICIPATE


Students, Research Scholars, and PhD Candidates pursuing graduate and postgraduate degrees from any field of study can participate in the competition.

- 4. **Certificates of Participation** will be provided to **all the participants.**






