ABOUT THE ESSAY COMPETITION

The initiative of organizing this competition started in 2018 with a motive to make the students think about the recent advancements in Constitutional Law and then pen them down using their own knowledge either analytically or critically. The competition also provides and exposure to the students by giving them an opportunity to receive their awards from some eminent legal luminaries. With student research oriented approach, this competition aims to make people aware about various constitutional provisions that requires some deliberation. The competition does not restrict the students to any particular topic and allows them, to think in all dimensions and pen down their thoughts regarding the recent or contemporary constitutional issues.

COMPETITION RULES

- 1. The last date of registration is March 31st, 2023
- 2. Eligibility: Law Students, Scholars, Academicians, Lawyers, Judges and Legal Professionals are eligible to participate.
- 3. Co-authorship is not permitted
- 4. Essays should be:
 - Original (Max 25% Plagiarism is allowed)
 - Not exceeding 2,500 words (excluding footnotes)
 - In English
 - Times New Roman with Font size 12 for the body of the Essay and Times New Roman with font size 10 for footnotes.
- 5. Footnoting Format shall be as provided by Indian law Institute. (ILI standard footnoting style).
- 7. Competition will be held in 2 levels:
- Level 1: Out of the submitted essays, top 5 essays shall be selected. (Results: 5th April)
- Level 2: The top 5 scorers shall present their paper in the Host College. Based on which the First, Second and Third prize shall be distributed. (Results: 15th April)
 - 8. Certificates will be provided to all participants.

PRIZES

1st Prize: INR 4,000 and Certificate 2nd Prize: INR 2,500 and Certificate 3rd Prize: INR 1,500 and Certificate

Winners will be awarded Hard copy of certificates

Hard Copy of Certificate of merit will be awarded to the top 5 winners.

Hard Copy of Certificate of Participation will be awarded to all the participants.

NOTE -Winners will be awarded at a valedictory ceremony at Law College Dehradun, Faculty of Uttaranchal University on 15th April, 2023 (tentative).
