Detailed Rules

CHAPTER I - INTRODUCTION

1. Short Title and Commencement

- a. These rules may be called ‘MEDIATION RULES AND PROCEDURE, 2023’.
- b. They shall come into force from the date of publication, on the official website of GIBS.

2. Definitions

In these rules, unless the context otherwise requires:

- a. “CLS-GIBS” refers to the Centre for Legal Studies, Gitarattan International Business School (hereinafter referred to as "CLS-GIBS"), affiliated to Guru Gobind Singh Indraprastha University.
- b. "Qualifying Rounds" refers to Preliminary Round I and Preliminary Round II of the Competition.
- c. “Advanced Rounds” refers to Semi-final and Final rounds.
- d. “Clarifications” refers to the queries arising out of the mediation problems that would only be accepted and reverted to in the timeline prescribed.
- e. “Competition” refers to the 3rd Mediation Competition at CLS, GIBS.
- f. “Institute” refers to the Centre for Legal Studies, Gitarattan International Business School (hereinafter referred to as "CLS-GIBS"), affiliated to Guru Gobind Singh Indraprastha University.
- g. “Judge” refers to a professional selected by the Organizing Committee to evaluate and score the teams’ performances during a mediation session in accordance with the judging criteria.

- h. “Mediating Pair” refers to the client and counsel pair of the participating team.
- i. “Mediation Session” refers to the timeframe for each round as specified in the rules below.
- j. “Mediator” refers to the third member of the Mediating Team who has applied and registered for the Competition as a participant.
- k. “Organizing Committee” refers to the body of student-faculty-staff of CLS-GIBS and includes any other person appointed by the Institute for the administration and functioning of the Competition.
- l. “Participants” refers to and includes only the bona-fide representatives of the University/ College/Institute who have applied and registered for the Competition by complying with the procedure prescribed hereinafter.
- m. “Requesting Party” and “Responding Party” refer to the competing team which argues on behalf of the party requesting the Mediation and the party responding to the request for Mediation at any given point in the Competition.
- n. “Team” refers to the Mediating Pair and Mediator representing their Institute.
- o. “Team Code” refers to the unique number allotted to the Team which would be used to identify them throughout the Competition.
- p. “Caucus” refers to the private meeting that each party holds with the mediator during the mediation. These private meetings give participants a chance to talk to the mediator freely, without the pressure of the other party being there. Anyone participating in mediation may request a caucus, including the mediator.

3. Interpretation

- a. The Organizing Committee shall reserve the right to interpret the rules as it may deem fit in the interests of the participants and the organisers to maintain fairness and equality in the Competition. The interpretation placed upon these Rules & Procedure shall be conclusive and the decision of the Organizing Committee regarding the application of these Rules & Procedure shall be final. Any such decision shall be binding on all the stakeholders and participants.

CHAPTER II - REGISTRATION

4. Eligibility

- a. Students pursuing their full time 3-year LLB or 5-year LLB program (1 team per program per institute) from a university or Institute recognized by the Bar Council of India, are eligible to apply.

5. Number of Teams

- a. Subject to the provisions of this Chapter, the Organizing Committee shall accept the registration of a maximum of **24 teams** on a first come first serve basis.

6. Registration Process

- a. The Mediation Competition will be conducted in the offline mode.
- b. The participants are required to register as a team of 3 students viz, a Mediating Pair (Client and Counsel) and a Mediator.
- c. The payment of registration fees amounting to Rs 2,700/- per team shall be made by the prescribed payment procedure. Registration fee is non-refundable in any case.

- d. The participating team shall mandatorily email a scanned copy of the duly completed Registration, Payment Form and Authorization Letter along with the receipt of payment on mediation@gitarattan.edu.in
- e. The participants must mail the payment screenshot/receipt to mediation@gitarattan.edu.in
- f. Registration will not be allowed without an authorization Letter from the college.
- g. The Organizing Committee shall send a confirmation of participation email after verifying the entire process as enlisted under the aforementioned clauses.
- h. Any failure or non-adherence with the aforementioned procedure may be treated as withdrawal from the competition and no claim of whatsoever nature shall be entertained thereafter.

CHAPTER III - THE COMPETITION

7. Format of the Competition

- a. The Competition shall comprise of Qualifying Rounds and Advanced Rounds.
- b. The Qualifying Rounds shall consist of two Preliminary Rounds and the Advanced Rounds shall consist of two rounds viz, Semi-Final Round and the Final Round.
- c. The draw of lots for the mediation competition will be in the format that in one room there shall be one client and one counsel from one team and one client and one counsel from the second team. There shall be two mediators in one room from different teams as that of the client and the counsels present.

For instance, in Room 1-

- Client - Counsel from team 1
- Client- Counsel from team 2
- Mediator from team 4 and team 5

d. This draw of lots shall be done prior to the competition and shall be mailed to all the participants along with the propositions for the qualifying rounds. For the subsequent rounds the draw of lots shall be done in front of the qualifying teams.

8. Composition of the team

- a. A Team shall be comprised of only 3 participants viz, Client, Counsel and Mediator.
- b. The Participants may change their roles within their Team only after the prior intimation and approval of the Organizing Committee.
- c. The composition of team members cannot be changed after registration.

9. Language

- a. The official and only language of the competition shall be English.

10. Structure of the Competition

- a. The competition will be held across a span of 2 days i.e., 2nd November 2023 and 3rd November 2023. Preliminary Rounds and Semi-Finals shall be conducted on 2nd November 2023 followed by the Final Round on 3rd November 2023.

b. Preliminary Rounds

- Each Team shall be once the Requesting Party and once the Responding Party in each session.
- No Team shall compete against the same team more than once in the Preliminary Rounds.

c. Semi- Final Round

- Top 4 teams from the Preliminary rounds shall qualify for the Semi-Final Round.

d. Final Round

- The top 2 teams from the Semi-Final Round shall qualify for the Final Round.

e. In case of a tie between the scores of two Teams in any round, the following component from the score sheet shall be considered as the tie-breaker.

- For the Mediating Counsel – Mediation Advocacy
- For the Mediator – Qualities of a Good Mediator

11. Time Period

The following shall be the time period for each round-

a. Preliminary Round I and II- 50 minutes each

b. Semi Final Round- 60 Minutes

c. Final Round- 90 Minutes

OPENING STATEMENT	20 Minutes (10 Min for each Mediator)

In case a Team exceeds the given time frame of the Mediation Session of any round, there shall be negative marking of -1 for exceeding every 2 minutes.

12.Mediation Problem

- a. The mediation problem(s) for all the rounds will be provided through mail 1 week prior to the competition.

13.Confidential Information

- a. Participants shall receive an email by the Organizing Committee carrying confidential information 30 minutes prior to the allotted time slot.
- b. Participants shall not disclose the confidential information to any other participant throughout the competition. Any such disclosure made to other participants before or after their round shall lead to immediate disqualification from the competition without scope of appeal.

14.Scope of Interpretation

- a. Participants shall restrict the interpretation of the problems to reasonable conclusions and are not allowed to create additional facts.

15.General Rules of the Competition

- a. There shall be two teams competing against each other in a Mediation room before the Judges.
- b. A Mediation Session shall comprise six people wherein there shall be two Mediators and two Mediating Pairs (each Mediating Pair shall comprise of a client and a counsel).
- c. The Mediator(s) shall lead towards a settlement between the two disputing parties.
- d. Breakup of time:
 - Each session shall go on for a time period as prescribed above in the Rules & Procedure.
 - In the aforementioned time frame, it is the discretion of the Mediator(s) to adopt the common code of procedure of the mediation session, provided that no such procedure shall contravene the general rules of the Competition at any cost.
 - No extra time shall be granted in any case whatsoever.
- e. Private Caucuses & Conferences
 - During the session, it is solely to the discretion of the Mediator(s) to call for caucuses or conferences, whichever he/she may want.
 - A caucus is a private meeting between one party and the Mediators while a conference is a joint meeting between both the parties and a Mediator.
 - However, the Mediator(s) shall call for at least one caucus or conference in order to facilitate the mediation process.

- Whenever the Mediator(s) calls for a caucus, the other party shall leave the room. The caucus shall take place between the Mediator and one party at once.
- During the call for a conference by the Mediator(s), both parties shall be present in the room.
- The Mediator(s) are permitted to call for both caucuses and conferences, whichever he/she may deem fit in the interest of the parties. Provided that the disputing parties may request the Mediator(s) to conduct a caucus.
- Team(s) may carry and use its own prepared notes for its own use and may, if need be, make its own notes during the Mediation Session. All notes must be written on paper.
- Usage of electronic devices during the session is strictly prohibited. No audio or videotaping of Mediation Sessions is permitted. Photography during the Mediation Session is also forbidden except the organizing committee.

16. Clarifications

- a. The Team(s) may submit queries regarding the mediation problems during the prescribed time frame. The response to the Clarifications is subject to the drafter's discretion. The Clarifications will not be accepted after 27th October 2023, 11:59 PM.
- b. All the clarification must be mailed to mediation@gitarattan.edu.in

17. Dress Code

- a. The dress code for the Competition shall be business formals.
- b. The above-mentioned dress code extends to the Inaugural and Valedictory Ceremony as well.

18. Winners

- a. Results will be declared in the Valedictory Ceremony on 5th November, 2023.
- b. The Team that scores the highest in the Final Round shall be declared as the “Winners”.
- c. The other Team that qualifies to the Final Round shall be declared as the “Runner-Up”.
- d. Best Mediator shall be declared on the basis of highest average marks obtained in the Preliminary rounds.
- e. Best Counsel shall be declared on the basis of highest average marks obtained in the Preliminary rounds.
- f. All winners will be awarded a cash prize and Certificate of Merit and every participant shall be awarded a Certificate of Participation.

CHAPTER IV- CODE OF CONDUCT

19. Code of Conduct applicable to Participants

- a. All the teams are bound to follow the code of conduct and the rules laid down by the organizing committee.
- b. Any behaviour of indiscipline with the Judges, Organizing Committee, any other staff member or student volunteer shall be dealt with strictly and may lead to immediate disqualification from the competition without scope of appeal.
- c. Any attempt to approach the framer(s) of the problem(s) or the panel of Judges of the Competition, prior to the Competition shall lead to immediate disqualification from the Competition without scope of appeal.

- d. All or any grievances are to be presented only to the grievance committee of the competition and the decision of the grievance committee shall be final and binding on the participants.

20. Anonymity of Teams

- a. After the registration of the teams, succeeding the receipt of acknowledgement, teams shall receive a unique Team Code, which shall be used to identify the teams during the course of the Competition.
- b. No participating Team shall reveal their identity in any form during the Competition, except by the means of the Team Code allotted to them.
- c. Any violation of the provisions of this rule shall attract severe penalty or disqualification as determined by the Organizing Committee. The decision of the Organization Committee in this regard shall be final and binding without scope of appeal.

21. Scouting

- a. No member of any team will be permitted to witness the proceedings in any room in which that team is not one of the participating teams whilst that team is a part of the competition. In case of any violation of the aforementioned rule, the organising committee shall take strict actions, which may include the expulsion of the said team from the competition.

CHAPTER V- MISCELLANEOUS

22. Power to make Amendments, Modifications or Revocations

- a. The Organizing Committee shall have power to amend, modify or revoke the provisions of these rules, either in part or in whole, subject to the feasibility, transparency and smooth functioning of the Competition.
- b. Any such amendment or modification shall come into force upon the notification of such amendment or modification as the case may be.
- c. Any such amendment or modification shall be deemed to be part of these rules.

23.Savings

- a. Nothing in these Rules & Procedure shall prejudice any right which any Participant would have had before the enactment of this Rules & Procedure.
- b. The Organizing Committee or the Institute shall not be held responsible for any actions of the Participants before or during the course of the Competition, which are violative under the present Rules & Procedure.

- a. Subject to the criteria and conditions laid down by the respective Colleges and Institutes, students pursuing their full time 3-year LLB or 5-year LLB program from a University or Institute recognized by the Bar Council of India, are eligible to apply.

3. Number of Teams

- a. The Organizing Committee shall accept the registration of a maximum of **24 Teams** on a first come first serve basis.

4. Application Process

- a. Only one team per course (3 year/ 5 year integrated course) per college/ institute/ university is allowed. Multiple entries from each college/institution are not allowed and the Organizing Committee shall accept the registration on a first come first serve basis.
- b. The team shall comprise two participants from the same college/university/institute.
- c. No Entries will be entertained without an Authorization Letter from the colleges/institutes/university.
- d. The participating team shall mandatorily email a scanned copy of the duly completed Registration and Payment Form along with the receipt of payment on debate@gitarattan.edu.in
- e. The Organizing Committee shall send a confirmation of participation email after verifying the entire process as enlisted under the aforementioned clauses.

- f. Once the registrations are done, no changes in names and roles within their Team shall be allowed.
- g. Any failure or non-adherence with the aforementioned procedure may be treated as withdrawal from the competition and no claim of whatsoever nature shall be entertained thereafter.

5. Registration Procedure

- a. The registration fee for the competition is Rs. 1,200/- per team.
- b. Each team shall register themselves through the registration form via link provided.
- c. The amount paid (registration fees) shall be non-refundable.

CHAPTER II - THE COMPETITION

Teams shall decide the time limit of speaker 1 and speaker 2 but the minimum time for a speaker is 4 minutes.
- Final Round-
 - The top 4 teams from the Preliminary rounds shall qualify for the Final Round.
 - Each Team shall debate either ‘against the motion’ or ‘for the motion’ which would be decided through a draw of lots to be conducted on the day of the event.
 - The total time allotted for each team is 20 minutes for presenting their statements and additional 10 minutes in totality to both the teams for rebuttal or sur-rebuttal for Final Round. Teams shall decide the time limit of speaker 1 and speaker 2 but the minimum time for a speaker is 8 minutes.
- c. Reading from any written document is prohibited. If in case, observed by the Judges/ organizers, the team would be disqualified.

7. Composition of Team

- a. A team shall comprise of only 2 participants from same college/ university/ institution.

8. Language

- a. The language for the debate competition shall be English only.

9. Clarifications

- a. The Team(s) may submit queries regarding the debate competition during the prescribed time frame to the debate@gitarattan.edu.in mail Id only. The Clarifications will not be accepted after the given time. The last date to seek clarifications is 24th October 2023, Tuesday 11:59 PM and the release of such clarifications would be on 29th October 2023, Saturday via the official email id debate@gitarattan.edu.in in a document form.

10. Dress Code

- a. The dress code for the Competition shall be business formals for both male and female participants.
- b. The above-mentioned dress code extends to the Inaugural and Valedictory Ceremony as well.

11. Winners

- a. Results will be declared in the Valedictory Ceremony on 5th September 2023 - Sunday.
- b. The team that scores the highest in the final round shall be declared as the “Best Team”.

- d. The competition simulates a law office consultation in which two participants (Counsel 1 and 2) deal with a client. The participants are given a brief written memorandum that identifies the client's problem prior to interviews. The participant team conducts an interview with a dummy client and the judge evaluates the performance. The topic of client counselling shall be provided on the spot.
- e. During the counselling period, students are expected to elicit the relevant information from the client, explore with the client his or her preferred outcome, outline the nature of the problem, and suggest to the client to resolve the problem.
- f. The participants will be evaluated by a panel of judges considering the specific criteria based on listening to clients, questioning, planning and analytical skills of a lawyer.
- g. During Post counselling and consultation, judges can ask questions to the competitor for further clarification.
- h. Team members are entirely free to decide the work distribution, but both competitors must consult with the client as a team. It will be the full discretion of the organizing committee to select and allot the clients.

6. Composition of team

- a. One team shall comprise two participants only (Counsel 1 and Counsel 2).
- b. In order to ensure wider participation, not more than one team from any particular institution shall be permitted to participate in the competition.
- c. If two teams of the same institution apply, the first registered team will be selected for participation.

7. Language

- a. The official and only language of the Competition shall be English.

8. Structure of the Competition

- a. The competition will be held on 3rd November 2023 - Friday.
- b. Preliminary Round
 - No Team shall compete against the same team more than once in the Preliminary Rounds.
- c. Final Round
 - The top 4 teams from the Preliminary Round shall qualify for the Final Round.

9. ROUNDS

a. PRELIMINARY ROUNDS

- There will be one Preliminary Round and each team will get one opportunity to represent themselves in the Preliminary Round. Each team will get a total of 25 minutes which are divided in two parts, as follows:
 - The first 15 minutes is termed as “Client Consultation period”.

b. FINAL ROUND

 - The first 25-minutes is termed as “Client Consultation period”.
 - Next 15 minutes is termed as the “Post Consultation Interview period”

c. CLIENT CONSULTATION PERIOD (Interview Period)

- In the client consultation period, the participants as lawyers are expected to elicit the relevant information, outline the problem, and propose a solution or other means of resolving the problem. During the consultation and post-consultation, the teams may use books, notes, and other materials.

d. POST CONSULTATION PERIOD (Post Interview Period)

- The remaining time from the total time as specified above will be for post-Consultation period and would be devoted for post-consultation among the participants/ lawyers, and includes Judges question– answer period.

In case of a tie, the scores shall be decided on the basis of the team scoring more points in the criteria of Legal Analysis and Giving Advice and Teamwork, in case of individual counsel for the Best Counsel Award, it shall be decided on the basis of the counsel scoring more marks in the criteria of Legal Analysis and Giving Advice and Establishing an effective professional relationship

10.Code of Conduct Applicable of Participants

- a. The official language of the competition shall be English. All written or oral submissions must be undertaken in English.
- b. All the participants must wear black pants and a white shirt formal dress for the entire duration of the competition. Girls are allowed to wear white kurti/black salwar. Use of advocate's gowns, bands and robes is strictly prohibited.
- c. No extra time will be allotted in any round without the permission of the judge. If any participant crosses the time - limit, a warning will be issued by the courtroom coordinator.

11. Grounds for Disqualification

Misconduct, whether behavioral or otherwise, is not allowed and if indulged into shall result in disqualification of the team. Misconduct shall include:

- a. Disclosure of identity to other participants or judges during the competition. The participants should use the Team Codes provided.
- b. Any attempt by participants to obtain the client counselling topic before notification.
- c. Any attempt by participant(s) to speak about controversial matters such as religion, caste, race, gender, foul language, or anti-national rhetoric before or during the competition.
- d. Any discussion with client(s) before competition.
- e. Cheating or using unfair means.
- f. Intimidation in any form.

CHAPTER – III MISCELLANEOUS

- a. To preserve anonymity, each team will be identified by a Team Code, which will be assigned to each team during the registration process. Disclosing the name of the participating college to the judges will result in disqualification.
- b. The decision of the Judges shall be final regarding the outcome of the Rounds.
- c. The Organizing Committee reserves the right to take any action against unethical, wrongful or unprofessional conduct.
- d. Scouting is not allowed under any circumstances and may lead to disqualification.
- e. If there is any situation, not covered by the Rules, the decision of the Organizers shall be final and binding.
- f. The Organizing Committee reserves the right to amend the rules. However, due notice shall be provided to all participating teams.

- g. The participants are always required to comply with the rules formulated by the Organizing Committee during the competition. In case of any non-compliance with the rules of the competition, a penalty may be imposed by deduction of marks and the teams may also be disqualified after they have been warned once.
