

ABOUT THE COLLEGE

To uphold the Sanatan values of life and to render quality education, Shri Brahmavarta Sanatan Dharma Mahamandal, the parent body of Vikramajit Singh Sanatan Dharma College, Kanpur was founded in 1916, seeking inspiration from Swami Dayanand ji, a great philosopher and promoter of Hindu Dharm. However, the Sanatan Dharma College, later known as Vikramajit Singh Sanatan Dharma College, Kanpur was established in 1921 under the guardianship of Rai Bahadur Babu Vikamajit Singh Ji. From its very inception, the college was famous as a college of commerce, to award Diploma in commerce was affiliated to Bombay University. In 1923 the college got affiliation from Allahabad University, Allahabad, to award degree of Bachelor of Commerce (B.Com.). The classes for Bachelor's and Master's degree in different other subjects began in 1925. Later in 1927 the college was affiliated to Agra University and LL.B. classes started in 1928. B.Sc. classes were started in 1956 whereas the M.Sc. classes began in 1964. Since 1967, the college is affiliated to C. S. J. M. University Kanpur. The College has been accredited 'A' grade by NAAC in 2009 & 2016 cycles. The college presently runs study programs under sixteen departments of six different faculties, namely, Arts, Commerce, Science, Teacher Education, Law and Physical Education. The College has celebrated its centenary in 2021. The Department of Law has been actively involved in legal research and organizing seminars, workshops etc.

ABOUT BARRISTER NARENDRAJIT SINGH JI

Barrister Narendrajit Singh was born on May 18, 1911, in the prominent social worker Rai Bahadur Shri Vikramjit Singh's home in Kanpur. He received education both in India and abroad. After passing the law examination in London, he became a barrister. He used to argue in Hindi in the courts and improved his Hindi by reading novels of famous authors. He was a specialist in company law, and lawyers from far and wide came to hear his arguments. In 1935, he married Smt. Sushila Ji, the daughter of Diwan Badrinath Ji of Jammu & Kashmir.

In the Rashtriya Swayamsevak Sangh (RSS), the role of the head of the family is significant. Barrister Narendrajit Singh devoted his life to this role in Uttar Pradesh. In 1944, he attended a Makar Sankranti celebration as the chief guest for the first time at a Sangh event. In 1945, he was appointed as a departmental head of the RSS, and in 1947, Shri Guruji declared him a Prant Sanghchalak. During the Emergency in 1975, he remained in jail. He was a man of principles. He believed that while politics may have glitz and glamour, serving society beyond that could be even more impactful.

Due to his love for education, several educational institutions were established in Kanpur by this family. In 1921, his father, Shri Vikramjit Singh, founded the "Sanatan Dharma Vani Commerce College" in Kanpur. After that, the family established a series of Sanatan Dharma colleges.

Barrister Sahab held positions in various religious and social organizations at the national and state levels. He passed away on October 31, 1993. Through his behavior, he demonstrated what it means to be the head of a family.

ABOUT THE DEPARTMENT

In the year 1927, the esteemed Department of Law at VS.S.D. College was established by the honorable Landlord of Nawabganj, Babu Shyamlal Ji, a true pioneer in his time. He was an erudite scholar with multiple prestigious degrees from the renowned University of Allahabad, including an M.A., LL.B., & M.R.A.S. During the British era, he served as Deputy Collector and also generously donated the land for the college's establishment. In addition to his many other accomplishments, Babu Shyamlal Ji also graciously accepted the roles of honorary law professor and hostel warden at the college.

Following in Babu Shyamlal Ji's footsteps, the late Pandit Kali Shankar Sharma became the principal of VSSD College in 1928 and served for many years. Rai Bahadur K.G. Banerji, former District and Session Judge, succeeded Pandit Kali Shankar Sharma out of compassion for the institution. In his illustrious career, Rai Bahadur K.G. Banerji was a highly respected attorney and intellectual who contributed significantly to governmental and non-governmental committees and even the High Court.

In addition to these venerable leaders, there were many others who have made invaluable contributions to the Department of Law over the years. Shri Badjikar Ji, Pt. Shri Babu Lal Misra Ji, Shri Ganga Ram Talwar Ji, Shri Gopi Shyam Nigam Ji, Shri H.P. Mudgal Ji, Shir G.K. Pandey Ji, Shri Harikishen Seth Ji, and Dr. A.S. Bhatnagar Ji, among others, have all held leadership positions within the department. Shri Badjikar Ji served as the Chairperson and Vice Chairperson of the College Management Committees for an extended period after his retirement. Subsequently, Pt. Shri Babu Lal Misra Ji became the Head of the Department, having already provided invaluable services as a professor of law for a significant period. The erudite Shri G.K. Pandey Ji headed both the law department at V.S.S.D. College and C.S.J.M. University.

REGISTRATION DETAILS

- Participants from any college pursuing a 3 year LLB course or a 5 year integrated LLB course shall be eligible to participate in the competition.
- Maximum two teams representing their college will be allowed from any one college.
- Every participating team shall have to produce a letter of permission from the end
 of their college showing that their particular team has been permitted to participate
 in the competition.
- Registration shall be conducted only through the online mode via the link provided below.
- Registration shall be considered as final only when the form is finally submitted and the receipt of payment has been uploaded.
- Registration Fee-Registration for the whole team shall be Rs. 400, which shall be without any lodging. With lodging it shall be Rs 1900 per team.
- Lodging shall be limited only to the team members and no one else shall be allowed to accompany the team.
- The registration fees shall be non-refundable and no claim for the refund shall be entertained at any cost.
- Each team shall be notified with their team code, once the cut-off date for registration has passed.
- The last date for registration shall be 16th November, 2023.
- QR code and Bank Details for payment of registration fees and accommodation charges
 have been appended at the end of the brochure.

GUIDELINES

- The dress code for the event shall be black and white formals with black tie and black shoes only.
- All the team members have to strictly follow the dress code during the whole event.
- The teams shall not disclose the identity of their college or their names during any stage of the competition. Anonymity has to be strictly maintained. Any contravention of this rule may lead to disqualification of the team from the event.
- Each team shall comprise of three members, i.e. two speakers and one researcher.
- Designation of the team members (Speaker 1, Speaker 2 and Researcher) shall be final and will remain same as entered while filling the registration form and further substitution of any individual for any designation is not allowed.
- Every team shall prepare one memorial from the side of plaintiff and one from the side of defendant.
- The team code has to be mentioned on the cover page of each memorial and also on every page of the memorial. The name of the memorials (for soft copy submission) shall also contain the team code.
- The petitioner's memorial shall also contain the letter 'P' along with the team code and similarly the respondent's memorial shall contain the letter 'R'.
- Every participating team should bring 4 copies of memorials each representing petitioner as well as respondent to be submitted before the preliminary round.
- Every memorial brought for submission should be in spiral binding.
- The name of the college and participants should not be written anywhere in the memorial.
- Any sort of delay in arrival of the teams at the venue during the oral rounds shall not be entertained.
- The cover page of every memorial should follow the designated colour code, blue colour for the petitioners and red colour for the defendants.
- Every memorial should contain the following-

- > The table of contents
- > The index of authorities
- > The statement of Jurisdiction
- > The statement of facts
- > The statement of issues
- > The summary of arguments
- > The argument advanced
- > The prayer
- The language for the competition will be bilingual. The participants are at will to use either of the two languages (English or Hindi).
- Memorials should be printed on single sides of A4 sized papers.
- The text should be in Times New Roman with font size of 12 pts., with 1.5 line spacing between the lines.
- Footnotes are required to follow the 10 pts font size with line spacing of 1 pt.
- One inch margin has to be maintained on all the sides of every page.
- All the citations should strictly adhere to the Bluebook citation style (20th edition).
- Competitors are required to adhere to the proper Court manners and etiquettes. Diversion from this may result in penalties in scores.
- The competitors are expected to carry their own resources and reference materials, as no material will be provided from the side of the organizing college.
- Oral rounds will be conducted in four stages, i.e. preliminary round, quarter-final round, semi-final round and final round.
- The result of every round will be decided on knock out basis and further in order to select the top 8 teams after the preliminary round, merit of the teams will also be considered.
- Oral Rounds will be of 25 minutes per team which may be divided according to the discretion of teams, provided that the minimum time that every speaker takes, shall be 10 minutes.
- Five extra minutes shall be provided to each team for rebuttal.
- Surrebuttal may be permitted on the basis of the discretion of the judges. If allowed, the duration of surrebuttal shall also be 5 minutes.

- Time for oral rounds in the final round shall be 35 minutes, out of which each speaker shall have to take minimum of 15 minutes. Rules regarding rebuttal and surrebuttal shall remain the same.
- Scouting during preliminary rounds shall be strictly prohibited. No team shall be allowed to enter the court room of any other participant.
- Scoring will be done on the following grounds-
 - ➤ Knowledge of Facts and Law
 - ➤ Use of Authorities and Precedent
 - > Response to questions and articulation
 - ➤ Advocacy skill
 - Court manners and etiquettes
 - > Time management
 - Points picked up in rebuttal and sur-rebuttal.

PRIZE AND AWARDS

- Certificate of merit shall be provided to the best team, runner up team, best memorial and best speaker.
- Prizes to be given as follows
 - > Best team to be awarded with prize money worth Rs. 5100.
 - > Runner up team to be awarded prize money worth Rs. 3100.
 - Best speaker to be awarded prize money worth Rs. 1100.
 - Best researcher to be awarded prize money worth Rs. 1100.
- Certificate of participation shall be given to all the participants.

MOOT PROPOSITION

The Asian sovereign state of Namibistan follows the parliamentary form of governance. With its large boundaries and huge population extending up to 150 crore, the state is governed by the principles of rule of law, which are protected by its apex court, the Supreme Court, which also functions as the highest Court of Record for the State.

The Constitution of Namibistan provides certain fundamental rights to its citizens, one of which is contained in Article 21which states the following- **Protection of life and personal liberty**- No person shall be deprived of his life or personal liberty except according to procedure established by law.

The Supreme Court has through one of its judgments, broadened the scope of right to life, to include the right to a dignified life and the other rights necessary for living a dignified life within its ambit. In another case Supreme Court has also held privacy to be essential for living a dignified life and thus making right to privacy a Fundamental right.

There is a company called 'Mega Services Pvt. Ltd.', headquartered in the state of Rihana, which operates on global level as a giant social media platform. This company has a sister company named as 'Telechat' which provides messaging service to the people in the state and across the globe. Both the companies control huge data and enjoy the status of being one of the world's biggest social media and messaging service provider.

In January 2021, Telechat updated the Privacy Policy and terms of services, which allows its parent company 'Mega Services Pvt. Ltd.' to access the data. Relevant portion of privacy policy as updated by the company is as follows-

• Third-Party Service Providers. We work with third-party service providers and other Mega Companies to help us operate, provide, improve, understand, customize, support, and market our Services. For example, we work with them to distribute our apps; provide our technical and physical infrastructure, delivery, and other systems; provide engineering support, cyber-security support, and operational support; supply location, map, and places information; process payments; help us understand how people

use our Services; market our Services; help you connect with businesses using our Services; conduct surveys and research for us; ensure safety, security, and integrity; and help with customer service. These companies may provide us with information about you under certain circumstances; for example, app stores may provide us with reports to help us diagnose and fix service issues. The section below provides more information about how Telechat collects and shares information with the other Mega Companies.

• Third-Party Services. We allow you to use our Services in connection with third-party services and Mega Company Products. If you use our Services with such third-party services or Mega Company Products, we may receive information about you from them; for example, if you use the Telechat share button on a news service to share a news article with your Telechat contacts, groups, or broadcast lists on our Services, or if you choose to access our Services through a mobile carrier's or device provider's promotion of our Services. Please note that when you use third-party services or Mega Company Products, their own terms and privacy policies will govern your use of those services and products.

How We Use Information

We use the information that we have, to operate, provide, improve, understand, customize, support, and market our Services. (This is subject to the choices you make and the laws as applicable) Here is how:

- Our Services. We use the information to operate and provide our Services, including customer support services; completing purchases or transactions; improving, fixing, and customizing our Services; and connecting our Services with Mega company products that you may use. We also use information to understand how the people use our Services; to evaluate and improve our Services; to research, develop, and test new services and features; and conduct troubleshooting activities. We also use your information to respond to you when you contact us.
- Safety, Security and Integrity. Safety, security, and integrity are an integral part of our Services. We use the information to verify accounts and activity; combat harmful

conduct; protect users against bad experiences and spams; and promote safety, security, and integrity on and off our Services, such as by investigating suspicious activity or violations of our Terms and policies, and to ensure our Services are being used legally. We use end to end encryption.

- Communications about Our Services and Mega Companies. We use information we have to communicate with you about our Services and let you know about our terms, policies, and other important updates. We may provide you marketing for our Services and those of the Mega Companies.
- Business Interactions. We enable you and third parties like businesses, to communicate and interact with each other using our Services, such as Catalog for businesses on Telechat through which you can browse products and services and place orders. Businesses may send you transaction, appointment, and shipping notifications; product and service updates; and marketing. For example, you may receive flight status information for upcoming travel, a receipt for something you purchased, or a notification when a delivery will be made. Messages you receive from a business could include an offer for something that might interest you. We do not want you to have a spammy experience; as with all of your messages, you can manage these communications, and we will honor the choices you make.

After updating the privacy policy, Telechat has not given option to its user for continuing the use of the platform without accepting the new privacy policy. Either they have to leave the platform or accept the updated the privacy policy.

One citizen of the state of Namibistan, Mathew Walker, has filed a Public Interest Litigation in the Supreme Court for the breach of privacy of users by the Telechat and accused the app of misusing its status and exploiting the users' data against their wishes. The Supreme Court has accepted the PIL and the case has been listed for hearing.

NOTE-All the laws of the state of India apply mutatis mutandis to the state of Namibistan.

एशियाई महाद्वीप में नामीबिस्तान नामक एक संप्रभु राज्य है। राज्य की आबादी लगभग 150 करोड़ और सीमा बहुत बड़ी है। राज्य में संविधान के आधार पर संसदीय शासन प्रणाली प्रचितत है। राज्य में सर्वोच्च न्यायालय भी है, जो राज्य में रिकॉर्ड की सर्वोच्च अदालत है। नामीबिस्तान के संविधान में कुछ मौलिक अधिकार हैं जिनमें अनुच्छेद 21 में कहा गया है कि-जीवन और व्यक्तिगत स्वतंत्रता की सुरक्षा- किसी भी व्यक्ति को उसके जीवन या व्यक्तित्व से वंचित नहीं किया जाएगा।

एक मामले का फैसला करते हुए सुप्रीम कोर्ट ने कहा कि जीवन के अधिकार में गरिमामय जीवन शामिल है और अन्य सभी अधिकार जो गरिमापूर्ण जीवन जीने के लिए आवश्यक हैं, इस अनुच्छेद के दायरे में आते हैं। एक अन्य मामले में सर्वोच्च न्यायालय ने कहा कि गरिमापूर्ण जीवन जीने के लिए गोपनीयता आवश्यक है और गोपनीयता का अधिकार भी मौलिक अधिकार है।

'मेगासर्विसेज प्राइवेट' नाम की एक कंपनी है। लिमिटेड' का मुख्यालयरिहाना राज्य में है, जो वैश्विक स्तर पर विशाल सोशल मीडिया प्लेटफॉर्म के रूप में काम करता है। इस कंपनी की एक सहयोगी कंपनी है जिसका नाम 'टेलीचैट' है। जो राज्य और दुनिया भर में लोगों को संदेश सेवा प्रदान करती है। दोनों कंपनियों के पास विशाल डेटा है और उन्हें दुनिया की सबसे बड़ी सोशल मीडिया और मैसेजिंग सेवा प्रदाता का दर्जा प्राप्त है।

जनवरी 2021 में, टेलीचैट ने गोपनीयता नीति और सेवाओं की शर्तों को अपडेट किया, जो इसकी मूल कंपनी 'मेगासर्विसेज प्राइवेट लिमिटेड' को डेटा को संसाधित करने के लिए अनुमित देती है। गोपनीयता नीति का प्रासंगिक भाग इस प्रकार है- • तृतीय-पक्ष सेवा प्रदाता। हम अपनी सेवाओं को संचालित करने, प्रदान करने, सुधारने, समझने, अनुकूलित करने, समर्थन करने और विपणन करने में सहायता के लिए तृतीय-पक्ष सेवा प्रदाताओं और अन्य मेगा कंपनियों के साथ काम करते हैं। उदाहरण के लिए, हम अपने ऐप्स वितरित करने के लिए उनके साथ काम करते हैं; हमारी तकनीकी और भौतिक अवसंरचना, वितरण और अन्य प्रणालियाँ प्रदान करना; इंजीनियरिंग सहायता, साइबर सुरक्षा सहायता और परिचालन सहायता प्रदान करना; आपूर्ति स्थान, मानचित्र और स्थानों की जानकारी; भुगतान प्रक्रिया; हमें यह समझने में सहायता करें कि लोग हमारी सेवाओं का उपयोग कैसे करते हैं; हमारी सेवाओं का विपणन करें; हमारी सेवाओं का उपयोग करके व्यवसायों से जुड़ने में आपकी सहायता करें; हमारे लिए सर्वेक्षण और अनुसंधान संचालित करें; सुरक्षा, सुरक्षा और अखंडता सुनिश्चित करें; और ग्राहक सेवा में सहायता करें। ये कंपनियाँ हमें कुछ परिस्थितियों में आपके बारे में जानकारी प्रदान कर सकती हैं; उदाहरण के लिए, ऐपस्टोर हमें सेवा समस्याओं का निदान करने और उन्हें ठीक करने में मदद करने के लिए रिपोर्ट प्रदान कर सकते हैं।

- व्यावसायिक सहभागिता. हम आपको और व्यवसायों जैसे तीसरे पक्षों को हमारी सेवाओं का उपयोग करके एक-दूसरे के साथ संवाद करने और बातचीत करने में सक्षम बनाते हैं, जैसे टेलीचैट पर व्यवसायों के लिए कैटलॉग जिसके माध्यम से आप उत्पादों और सेवाओं को ब्राउज़ कर सकते हैं और ऑर्डर दे सकते हैं। व्यवसाय आपको भेज सकते हैं

गोपनीयता नीति को अपडेट करने के बाद, टेलीचैट ने अपने उपयोगकर्ता को विकल्प नहीं दिया है, या तो उन्हें प्लेटफ़ॉर्म छोड़ना होगा या अद्यतन गोपनीयता नीति को स्वीकार करना होगा।

नामीबिस्तान राज्य के एक नागरिक, मैथ्यूवॉकर ने टेलीचैट द्वारा उपयोगकर्ताओं की गोपनीयता के उल्लंघन के बारे में सर्वोच्च न्यायालय में एक जनहित याचिका दायर की है और टेलीचैट पर स्थिति का दुरुपयोग करने और उपयोगकर्ताओं के डेटा को उनकी इच्छा के विरुद्ध शोषण करने का आरोप लगाया है। सुप्रीम कोर्ट ने जनहित याचिका स्वीकार कर ली है और मामला सुनवाई के लिए सूचीबद्ध है।
