ELIGIBILITY

TEAM COMPOSITION

- Participants from each team shall follow the sequence for debating their points as '**For-Against**'.
- The marking shall be done by the judges on the following parameters:
 - (a) Content and quest of knowledge
 - (b) Delivery and presentation skills
 - (c) Answer to the question presented by the Judges
- The preferred medium of debate is English only, however, quotes can be delivered in Hindi.
