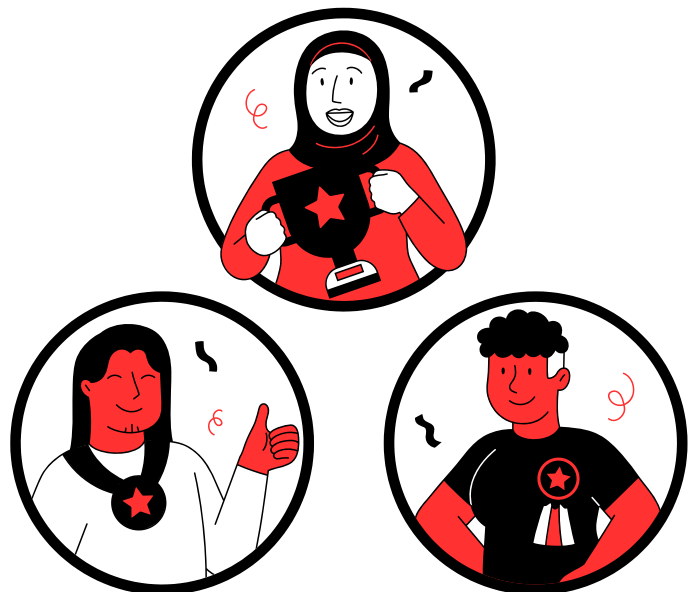

Mentors will guide participants to understand arbitration cases and practice like an arbitrator and arbitration counsels.

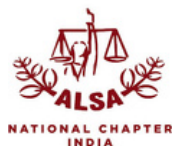
## **Session 08: Lok Adalat**

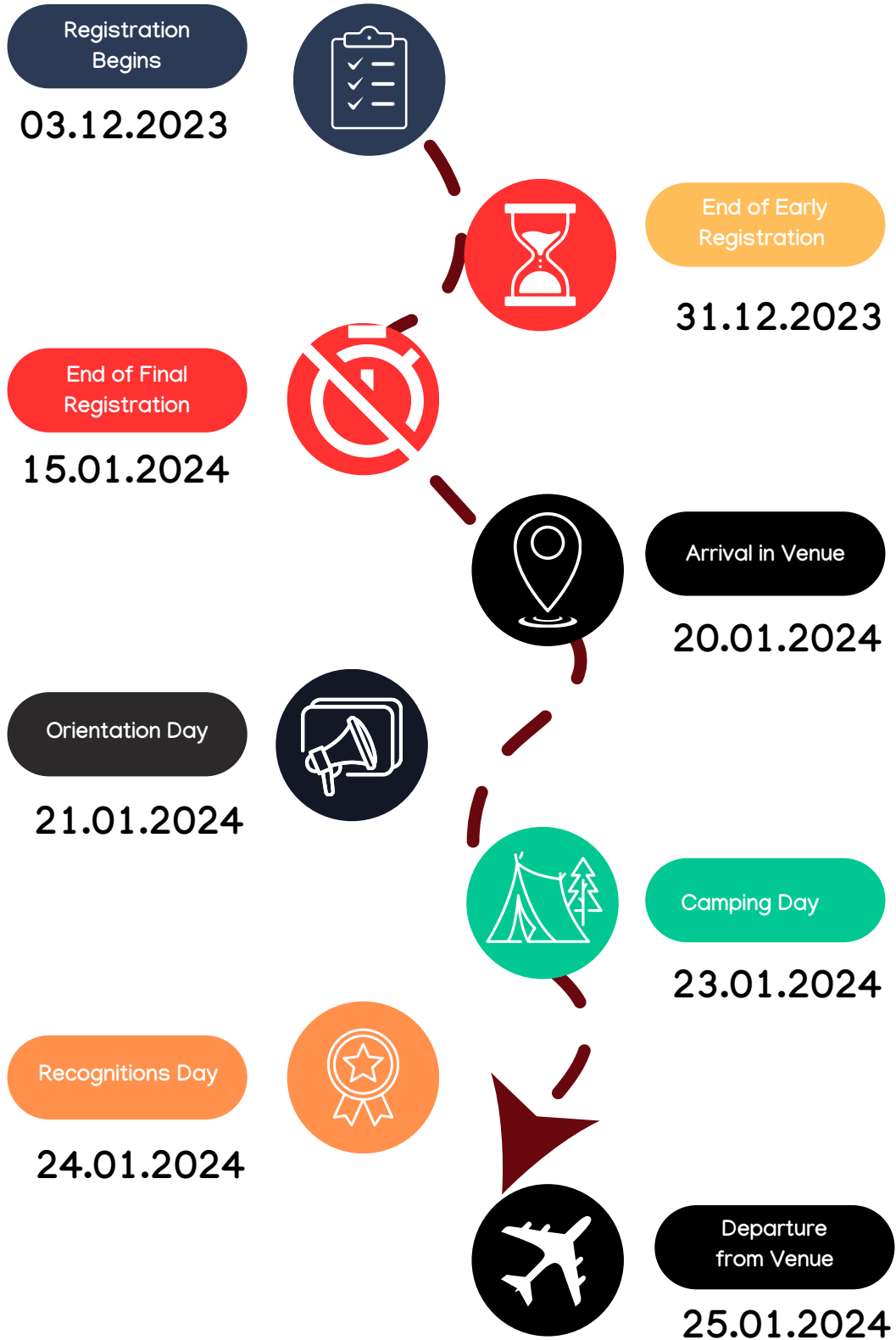

# PROGRAM TIMELINE

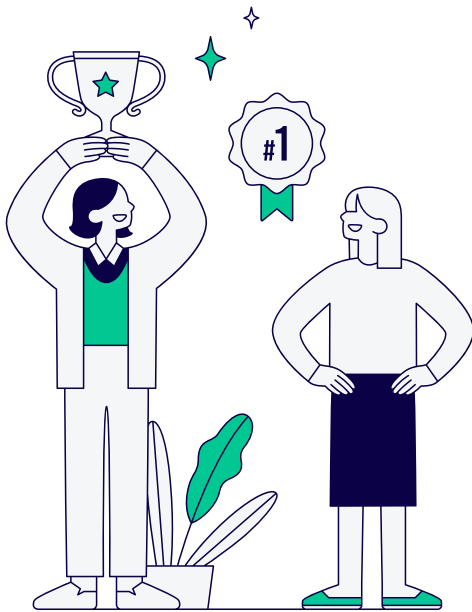

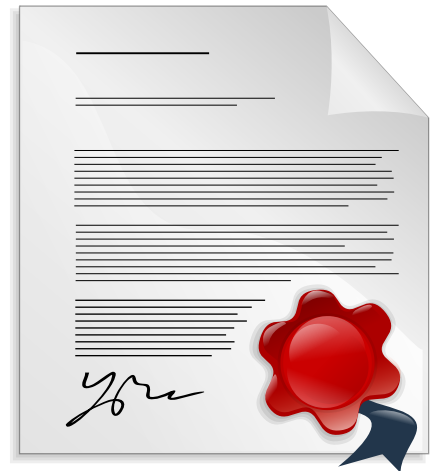
