MOOT PROPOSITION Public Voice versus State of Bardia

- 1. The Republic of Bardia, is the world's largest democracy with the highest population. It is renowned for its diversity in population, culture, religion, and ethnicity. The majority of Bardia's citizens follow the Sanafia religion, followed closely by the Marshia religion. Bardia is among the world's rapidly developing economies. It also has a rich heritage deeply rooted in ancient literature, scriptures, and inscriptions. The country's natural abundance of resources has historically attracted numerous invaders who sought to settle within its borders. Bardia, once considered the world's golden sparrow due to its wealth and robust economic growth. It witnessed native rulers who extended their territories and economic activities far beyond what is now defined as the continental shelf. The architectural marvels of Bardia stand as evidence of early engineering prowess in its society. This country is often regarded as the birthplace of many early technical knowledge systems, a subject of ongoing debate regarding its historical significance.
- 2. Bardia is home to the Hariyali Mountains, known as the "abode of snow" in the North, and the Konkonda Ranges in the South. The country boasts numerous perennial rivers, a significant asset that positions Bardia as a promising nation for yielding substantial profits in the global market. This appeal is bolstered by its abundant resources, youthful workforce, and political stability, which attract multinational companies and international organizations alike.
- 3. Despite its abundant natural resources, a significant portion of Bardia's population resides in villages, facing issues of unemployment and illiteracy.

- 4. Bardia is renowned for its advanced medical services, which are predominantly concentrated in metropolitan areas. However, it is important to note that approximately 70% of the population resides in rural villages.
- 5. Due to advancements in affordable medical technology, the country has garnered the attention of individuals worldwide. People from around the globe travel to Bardia for various medical treatments. Approximately 30% of the country's GDP is derived from this sector. The 21st century saw a proliferation of fertility hospitals across the nation. Couples from Western countries sought Bardia as a cost-effective destination for surrogacy treatments. While these activities appeared to be a boon for the country, they were accompanied by various challenges.
- 6. In response to numerous incidents of high maternal mortality and morbidity rates, particularly in rural areas, the Ministry of Health in Bardia conducted a survey in collaboration with NGOs dedicated to the welfare of women and children. The objective was to gather data related to abortion rates and maternal mortality.
- 7. The survey's findings were profoundly startling. The data revealed a deeply concerning trend in the increasing maternal mortality rate attributed to unsafe abortions. It highlighted that in Bardia, 56% of abortions were conducted under unsafe conditions. Out of the annual 6.4 million abortions in Bardia, 3.6 million were performed using unsafe methods, contributing to a 13% maternal mortality rate in the country. Furthermore, the data revealed that 52.9% of abortions occurred in private hospitals, 26.2% were conducted without any medical supervision, especially within individuals' homes, 0.6% through other means, and only 20.3% took place in government hospitals.

- 8. Bardia is a member of the United Nations and a signatory to several International agreements, including the Universal Declaration of Human Rights (UDHR), the International Covenant on Civil and Political Rights (ICCPR), the International Covenant on Economic, Social and Cultural Rights (ICESCR), the Convention on the Rights of the Child, and the Convention on the Elimination of All Forms of Discrimination against women.
- 9. The World Health Organization (WHO), a vital UN agency responsible for health, recently released a report titled "Induced Abortion in the 21st Century." This report highlights the increasing number of fatalities resulting from unsafe induced abortions and delves into the psychological challenges faced by women in relation to abortion. The report underscores the alarming rise in maternal mortality linked to unsafe induced abortion.
- 10. In consideration of the above instances, the State of Bardia introduced the Medical Termination of Pregnancy Amendment Bill, 2018, which was subsequently passed in both houses of parliament.
- 11. Two years after the amendment, the Ministry of Health in Bardia initiated a study to assess the Act's effective implementation. The study revealed a significant reduction in cases of unsafe induced abortions. The percentage of abortions conducted without medical supervision, primarily within individuals' homes, decreased to 23.9%, compared to the earlier rate of 26.2%. Similarly, other methods of abortion reduced to 0.4% from the previous rate of 0.6%. Additionally, it was noted that the rate of abortions performed in Government Hospitals had increased to 1.6%.

- 12. It was also found even after the amendment, there was a sudden spike of 8% in the foeticide rate during this period in the country. There were many incidents reported in the digital world through many medium and this got the attention of a huge population. The social media carried a heavy number of visual recordings of such reports and few were still unreported and discovered. The one which currently is the talk of the town has grabbed the attention due to their celebrity status.
- 13. The NGO "People's Voice" was found in 1975 which is a fore runner in protecting and upholding Human rights especially with respect to women and children. The NGO is the pillar of strength and support in comforting the women community who have been betrayed and abandoned by their own families. There are multiple surveys and interviews being held under the able guidance of this organization. Even in the past the organization with its missionary vision was a protecting force in confirming the fundamental rights of the deprived section of the society. The NGO being a human rights activist has filed many public interest litigation in the past and has ensured the delivery of justice to the oppressed. The organization played a pivotal role in quenching the thirst for fundamental rights of many individuals.
- 14. Meanwhile, Kate's dream director, Mr. Bellgem, a master in the field of direction and an international icon, who has been honoured with Oscar and several other prestigious international awards. He has presented her with a one-of-a-kind opportunity to play a lead role in his upcoming movie. This role has the potential to enhance her chances of receiving an Oscar nomination. The dream for Oscar persuaded her interest of experiencing motherhood.

- 15. Kain was devastated by the fact that Kaith has made the decision to undergo an abortion without his knowledge. In response to this tragic event, Kain turned to social media to express his sorrow and disappointment over the loss of their first unborn child and his partner's action. This incident garnered extensive Social Media attention across the country, making the couple the centre of discussion.
- 16. Observing this news on social media and considering various reports concerning the rising rate of foeticide, "People's Voice" decided to gather more details about foeticides and pregnancy terminations by conducting interviews with all relevant stakeholders. However, these efforts proved to be in vain. Consequently, "People's Voice" made the decision to file a Public Interest Litigation, before The Honourable Supreme Court of Bardia seeking the intervention of the Judiciary in this matter to ensure justice and protection.

The Laws in the state of Bardia are parametria to the laws in the Republic of India.


