1. GENERAL RULES:

1.1. "Organizers" and "Organizing Committee" means the Adamas Law Moot Court Committee and the Volunteer, School of Law and Justice, Adamas University.

1.2. "Competition" means the 4th Adamas National Moot Court Competition, 2024.

1.3. "Participating Team" means the team that has registered itself for the competition as per the rules given below.

1.4. "Participants" means the speakers and the researcher of the Participating Team.

1.5. "Administrator" shall mean School of Law and Justice, Adamas University.

1.6. "Appellant" shall include Appellant, Plaintiff, Petitioner, Complainant, Prosecution, Informant, etc.

1.7. "Bench" refers to the members duly invited to adjudge the oral rounds, collectively.

1.8. "Clarifications" means an explanation published by the Host University on the moot problem, at any point of time of the competition to a query posed by any participating team within the given deadline.

1.9. "Compendium" means a compilation or collection of legal or other authorities that a participating team seeks to rely upon during the round of oral pleadings.

1.10. "Host University" shall have the same meaning as "Administrator" for this edition of the Competition.

1.11. "Moot Proposition" means the Proposition released by the Organizers and shall include any subsequent clarification(s) as and when issued by the Organizers.

1.12. "Oral Score" means the scores given by the judge to a particular orator of the participating team pleading before it during the round of oral assessment.

1.13. "Orator" means one of the two designated speakers in a participating team.

1.14. "Organizers" means the School of Law and Justice, Adamas University and Adamas Law Moot Court Committee.

1.15. "Participating Team" means the team that is eligible to participate in the competition after completion of the registration procedure.

1.16. "Participating Institution" shall be presumed to be the parent institution of the participating teams.

1.17. "Researcher" means a team member who will sit with the teams at the Oral Rounds but shall not be permitted to address the Court during the Oral Rounds. The Researcher may, however, be permitted to pass notes to the Speakers at the discretion of the Judges. The researcher shall be the only person allowed to take the Researchers Test.

1.18. "Respondent" shall include Defendant, Respondent, Defence, etc.

1.19. "Rules" means the 4th Adamas National Moot Court Competition Rulebook.

1.20. "Team Code" means a unique code assigned by the Host University to the registered participating team. Every team that has successfully completed the Registration requisites under the Rules shall be allotted a unique code after the closure of the Registration for the Competition. Once the Code is allotted, every team must use only the team code for any further communication with the Organizers during the course of the Competition.

1.21. "Written Score" means the scores given by the organizers to a particular participating team on the written submissions submitted by them according to the rules of the Competition.

1.22. "Written Submissions" means the memorandum of written submissions (memorials) submitted by any participating team according to the rules of the Competition.

1.23. The rules of the Moot Court shall be strictly adhered to. Any deviation from them would attract disqualification or other penalties as decided by the Organizers.

1.24. Decisions taken by the Organizers in case of any doubt, dispute, disqualification etc. shall be final.

1.25. Venue: Adamas University, School of Law and Justice.

2. DATE AND MODE OF THE COMPETITION:

2.1. The Moot Court Competition shall be held from 21st March to 23rd March, 2024.

2.2. Mode: Offline.

3. ELIGIBILITY:

3.1. Participation is restricted strictly to bona fide law students pursuing the three-year or fiveyear LL.B. degree course in any institution in India. Students doing their LL.M. and Diploma courses are not eligible for participation.

3.2. Only 3 (Three) teams are permitted to participate from each participating institution.

4. TEAM COMPOSITION:

4.1. Each team shall comprise a maximum of 3 members and a minimum of 2 members consisting of 2 speakers and 1 researcher. The number cannot be modified under any circumstances. Any change in team composition must be intimated to the Organizer at the earliest.

4.2. Teams shall identify the speakers and researcher at the time of Registration. No extra member or observer shall be allowed. Also, no deviation from the chosen names shall be allowed after the process of registration.

5. REGISTRATION:

5.1. All the participating institutions have to confirm participation by duly filling out the Registration form on or before 12th March 2024.

5.2. The registration will close on 12th March, 2024. The Registration shall be done by filling up the Registration Form available on Google Form: <u>https://forms.gle/AsjrFYdzf9A7TFPt6</u>

5.3. Every team that has successfully completed the Registration requisites under the Rules shall be allotted a unique code after the closure of the registration for the Competition. Once the Code is allotted, every team must use only the **team code** for any further communication with the Organizers during the course of the Competition.

5.4. The participating Team is required to pay Rs. 1,500/- for those who are not availing Accommodation or Rs. 4,000/- for those who are availing for Accommodation. The registration fees (as applied) must be paid by NEFT or IMPS. The last date of payment is on 12th March, 2024.

5.4 Non-payment of Registration Fees shall result in the cancellation of Registration of the Participating Team.

5.5 This fee is exclusive of the travel to and from the campus to the airport/ railway station/ bus station. It is the sole responsibility of the teams to arrange for the travel when they arrive and leave the campus.

6. RULES REGARDING WRITTEN SUBMISSION:

6.1. Submission Guidelines:

6.1.1. Teams are required to submit memorials from each side i.e., from the side of Petitioner/Appellant and the side of Defendant/Respondent.

6.1.2. The soft copies of the written submission from each side should reach the Organizers in the given Google Form: <u>https://forms.gle/v53kD44kMD8RG2kT8</u> in ".pdf" format by **11:59 PM**, **19th March 2024**.

6.1.3. Written Submissions from both sides shall be sent in a single Google Form.

6.1.4. Teams are required to submit 5 (five) Hard Copies of the memorial on 21st March
2024 during physical verification. The Hard Copies must be in SPIRAL BINDING.

6.1.5. The hard copy of the written submission must be an exact replica of the soft copy submitted with the Organizers. Any difference in the same will result in disqualification from the Competition.

6.1.6. The teams must carry copies of the written submission from both sides for their own reference.

6.1.7. Petitioner memorials must have a **BLUE COVER** and Respondent memorials must have a **RED COVER**.

6.1.8. The memorials shall not contain any form of identification apart from the team code. If any such identification or mark, symbol, etc. which has the effect of identifying the team is found on the memorial, then it shall result in instant disqualification.

6.2. Format of Memorial

6.2.1. Each memorial shall have the following details:

- Cover Page The cover page shall contain the case title, side of the written submission, year of competition, name of the forum and team Code on top right corner
- Table of Contents
- List of Abbreviations
- Index of Authorities The Index of Authorities must list all the authorities cited and also all the cases cited in the Written submission. The Index must indicate the page number(s) and/or the paragraph number(s) of the Written submission in which the authority is cited.
- Statement of Jurisdiction
- Statement of Material Facts The Statement of Material Facts must contain a concise statement of the relevant facts of the dispute. As far as may be, the Statement of Facts should be limited to the stipulated facts and legitimate inferences which can be drawn from those facts. Argumentative facts are prohibited.
- Statement of Issues
- Summary of Arguments The Statement of Material Facts must contain a concise statement of the relevant facts of the dispute. As far as may be, the Statement of Facts should be limited to the stipulated facts and legitimate inferences which can be drawn from those facts.
- Arguments Advanced
- Prayer

6.2.2. The Cover Page must contain the following details:

- Team code on the top right-hand corner of the cover page.
- Name and place of the forum.

- Name of the parties and their status.
- Memorial submitted to ...
- Memorial led and appearing on behalf of ...

6.2.3. Content Specification

The following content specifications must be adhered to:

- Language English
- Team Code: The team code must be ascribed on the top right corner of the cover page. The code must be succeeded by the side for which the written submission is prepared. The teams must use P for "Petitioner" and R for "Respondent." For example: in case the Team Code is TC-100 the team must write "TC-100P" in case of written submission for Appellant and "TC-100R" in case of written submission for Respondent.
- Font and Size (Body) Times New Roman, 12 pts
- Line Spacing (Body) 1.5 lines Font and Size (Footnotes) Times New Roman, 10 pts
- Line Spacing (Footnotes) Single line
- Page Margins 1 inch on all sides
- Page Limit 25 pages maximum
- Paper Specification White A4 Sized Paper
- Body of the Memorial Justified The citation should be in compliance with the Bluebook: A Uniform System of Citation (21st Edition).

Non-compliance with respect to the formatting given above will result in a penalty of 1 mark for each missing point.

6.3. Evaluation of Written Submission:

Memorials will be judged by a special panel of judges on the basis of the following criteria:

6.4. Penalties:

6.4.1. Submission done after the prescribed date will attract a penalty of 5 marks for each day of delay.

6.4.2. Violation of any rules stated will attract a deduction of 10 marks for such violation.

6.5. Dress Code:

6.5.1. Inside the courtroom, participants shall be in formal wear only. However, robes and collar bands are not allowed.

6.5.2. Female participants are required to wear either a full suit comprising of black formal blazer and trousers, full-sleeved white shirts or a white kurta, white bottom wear, black blazer/overcoat with formal footwear.

6.5.3. Male participants are required to wear a full suit comprising of black formal blazer and trousers, full-sleeved white shirts, black tie and formal footwear.

6.6. Anonymity

6.6.1. Participants shall not disclose their names and identities at any time before the award ceremony. The individual code and the team code shall be the sole source of identity of the respective teams throughout the competition. Any disclosure against this rule shall invite penalty including disqualification.

6.7. Clarification

Clarifications to the Moot Proposition shall be sought by sending an e-mail to <u>solj.mootcourt@adamasuniversity.ac.in</u> on or before 15th March, 2024. <u>Clarification</u> <u>requests sent after this date shall not be entertained</u>. The organizers shall release the clarification/ clarifications on or before 17th March 2024.

The mail shall bear a subject line as "CLARIFICATION ANMCC".

N.B. – No clarification and/or query shall be sought from any individual who is a member of the Organizing Committee in a personal capacity. Any attempt to do so shall result in direct disqualification from the competition.

7. INAUGURATION:

The formal inauguration of the 4th Adamas National Moot Court Competition will be held on 21st March, 2024.


8. DRAW OF LOTS:

The match-up of teams in Preliminary Rounds be determined on the basis of the draw of lots which shall take place on 21st March, 2024.

9. ORAL PLEADING ROUNDS

9.1 The language to be used during the Oral Pleading Rounds shall be exclusively English.

9.2. The Competition shall consist of the following rounds:



9.3. During each of the abovementioned rounds, the order in which the teams shall present their arguments is as follows:

- Appellant Speaker 1
- Appellant Speaker 2
- Respondent Speaker 1
- Respondent Speaker 2
- Rebuttal: Appellant Any one of the two Speakers (as applicable)
- Sur-rebuttal: Respondent Any one of the two Speakers (as applicable)

Sur-rebuttal may be permitted only at the discretion of the Judges.

9.4. The Researcher shall be allowed to sit with the teams at the Oral Rounds but shall not be permitted to address the Court during the Oral Rounds. The Researcher may, however, be permitted to pass notes to the Speakers at the discretion of the Judges. Such notes shall be passed through the court clerks present in the courtroom. The researcher shall be the only person allowed to take the Researchers Test.

9.5. Teams are not permitted to raise issues in the Oral Rounds that have not been submitted in the Written Submissions.

9.6. The use of mobile phones, laptops, or any other electronic gadgets is strictly prohibited during the Oral Rounds, subject to the discretion of the judges.

9.7. Participants may use their own bare acts, printouts and commentaries provided that anonymity is not violated during the Rounds.

9.8. Participants shall ensure that anonymity is not violated while passing on any material to the Judges. No mark, name, seal, symbol or logo of the institution/college/university must be present. Participants must ensure that the same is rendered unrecognizable.

9.9. The decision of the Judges as to the marks allotted to each team shall be final and binding.

9.10. Teams shall notify the Court Clerks of the division of time between the 2 Speakers (including time reserved for Rebuttal & Sur-rebuttal) 10 minutes before the commencement of the Rounds.

9.11. If Speaker 1 exceeds his/her reserved time, the additional time taken shall be deducted from the time reserved by Speaker 2. Similarly, if Speaker 2 exceeds his/her reserved me, the additional time taken shall be deducted from the time reserved for Rebuttals/Sur-Rebuttals as the case may be. This rule may not be followed if the additional time is awarded at the discretion of the Judges to not be deducted from the time of the subsequent Speaker.

9.12. While granting additional time, if the additional number of minutes granted is not specified by the Judges, it shall be presumed that the additional time granted is 2 minutes.

9.13. The finality of the decision as to the time structure and the right to Rebut or Surrebut shall vest with Judges.

10. STRUCTURE OF COMPETITION

10.1. Preliminary Round

- There will be one (1) Preliminary Rounds to ensure that each team is allowed to argue.
- The fixtures for the Preliminary Rounds shall be determined by drawing of lots.
- This will be a knockout round.
- Eight (8) teams shall qualify for the Quarter Final Rounds on a knock-out basis, i.e., the winner of each Preliminary Round shall qualify for the Quarter Final Rounds. The knockouts will be decided based on the scores of the oral rounds only.

- Each team shall be given only 20 minutes to present their argument and 5 minutes will be allotted for the rebuttals and sur rebuttals. A speaker can argue for a maximum of 15 minutes.
- For the Preliminary Rounds, the winner of each such round shall be determined based on the criteria of evaluation of the memorials scores and the speaker scores, as mentioned in the Rules below.
- "Best Speaker" of the competition shall be selected based on the marking of the Preliminary Round.

10.2. Quarter Finals

- The eight (8) teams that proceed to the Quarter Final Rounds, as determined by the Rules above, shall each argue only ONCE for the side allotted by a draw of lots.
- Each team will get a total of 20 minutes to present their arguments and 5 minutes will be allotted for the rebuttals and sur rebuttals. A speaker can argue for a maximum of 15 minutes.
- Four (4) teams shall qualify for the Semi Final Rounds on a knock-out basis, i.e., the winner of each Quarter Final Round shall qualify for the Semi Final Rounds. The knockouts will be decided based on the scores of the oral rounds only.
- In case of a tie, the team with higher aggregate speaker scores will be declared the winner for that round. If the aggregate speaker scores of the teams are the same, then the team with a higher gross memorial score i.e., the score of the memorial without deducting penalties shall be ranked higher.
- Below here mentioned is the arrangement of teams for the Quarter Final Rounds of the 4th Adamas National Moot Court Competition, 2024:

Rank 1 of Prelims vs Rank 8 of Prelims Rank 2 of Prelims vs Rank 7 of Prelims Rank 3 of Prelims vs Rank 6 of Prelims Rank 4 of Prelims vs Rank 5 of Prelims

10.3. Semi-Final:

• The four (4) teams that proceed to the Semi Final Rounds, as determined by the Rules above, shall each argue only ONCE for the side allotted by a draw of lots.

- Each team will get a total of 30 minutes to present their arguments and 5 minutes will be allotted for the rebuttals and sur rebuttals. A speaker can argue for a maximum of 20 minutes.
- Two (2) teams shall qualify for the Semi Final Rounds on a knock-out basis, i.e., the winner of each Quarter Final Round shall qualify for the Semi Final Rounds. The knockouts will be decided based on the scores of the oral rounds only.
- In case of a tie, the team with higher aggregate speaker scores will be declared the winner for that round. If the aggregate speaker scores of the teams are the same, then the team with a higher gross memorial score i.e., the score of the memorial without deducting penalties shall be ranked higher.
- Below here mentioned is the arrangement of teams for the Committee Semi Final Committee Rounds of the 4th Adamas National Moot Court Competition, 2024:

Rank 1 of Quarter Final Round vs Rank 4 of Quarter Final Round. Rank 2 of Quarter Final Round vs Rank 3 of Quarter Final Round.

10.4. Final:

- The two (2) teams that proceed to the Final Rounds, as determined by the Rules above, shall each argue only ONCE for the side allotted by a draw of lots.
- Two (2) teams shall qualify for the Final Round on a knock-out basis, i.e., the winner of each Semi-Final Round shall qualify for the Final Round.
- Each team will get a total of 40 minutes to present their arguments and 5 minutes will be allotted for the rebuttals and sur rebuttals. A speaker can argue for a maximum of 20 minutes.
- In case of a tie, the team with higher aggregate speaker scores will be declared the winner for that round. If the aggregate speaker scores of the teams are the same, then the team with a higher gross memorial score i.e., the score of the memorial without deducting penalties shall be ranked higher.

10.5. Oral Submission Scoring Break up:

11. SCOUTING

11.1. Scouting is strictly prohibited.

11.2. Any person may submit a complaint regarding Scouting to the Organizers.

11.3. Teams found scouting shall be disqualified immediately.

12. DELAY IN APPEARANCE/PRESENTATION

If a team scheduled to take part in any Round does not appear within 10 minutes of the scheduled time, the other team present shall be allowed to submit *ex-parte*.

13. RESEARCHERS TEST

- The Researcher's Test shall be conducted on 21st March, 2024.
- In each team consisting of three members, only the member designated as Researcher shall take part in the test.
- Participants are requested to write only the Team Code on the question paper.
- The Researcher's Test shall be objective with questions based on the applicable law, precedents and facts pertaining to the Moot Proposition.
- The duration of the Researcher's Test shall be 60 minutes.
- The Researcher's test shall consist of 50 (fifty) objective-type questions carrying 2 (two) marks each. No deduction will take place in case of the wrong answer.
- No additional material such as the bare text of Acts, Written Submissions, etc. apart from stationery may be brought by the participant to the test and no such material shall be provided by the Organizers.

- The score of the Researcher's Test shall be computed as the total of Score in the Researcher's Test. [Note: In case two or more students score the same aggregate marks in the Researcher's test, a higher rank will be awarded to the student scoring more marks in the written submission of the memorials.]
- The Winner of the Test shall be determined by the highest score attained.

14. AWARDS:

- Best Team: the team winning the final round of the Competition shall be awarded with Rs. 50,000, a trophy and certificate.
- 1st Runners-Up: the runners-up team in the final round of the Competition shall awarded with **Rs. 25,000**, a trophy and certificate.
- 2nd Runners-Up: the 2nd runners-up team in the final round of the Competition shall awarded with **Rs. 10,000**, a trophy and certificate.
- Best Speaker: The speaker having the highest score in the preliminary rounds shall be awarded with **Rs. 5000** a trophy and certificate.
- Best Researcher: The participant having the highest score in the researcher's test shall be awarded **Rs. 5000**, a trophy and a certificate.
- Best Memorial: The participant having the best memorial will be awarded Rs. 5000
- Certificates of merit shall be given to all the teams qualifying for the Quarter-finals and beyond.
- Certificate of participation shall be given to all the participating teams.

15. MISCELLANEOUS

- If any one member of a team is notified or informed of any detail or information concerning the Competition, it shall be deemed as if the said team as a whole has been duly notified or informed.
- The copyright in the Written Submissions of Teams shall vest with Adamas University School of Law and Justice. We shall not be responsible for any liability accrued to any person or for any loss caused to any person because of the content of the Written Submissions.
- No audio recording or videotaping of oral pleadings is permitted without the permission of the Organizers, the Bench before which the team is scheduled to present, and the

opposing Team. The Organizers reserve all rights to audio recording and videotaping, or any other form of audio or visual reproduction of any oral round or part thereof.

- Team(s) shall not approach the Bench with any complaints, under any circumstances whatsoever.
- FORCE MAJEURE In case of any event, which includes but is not limited to, a declaration of war, a disease epidemic, imposition of lockdowns and curfews, any riots, a cyclonic storm, an earthquake, or any other natural disaster due to "Act of God", the date of the competition may be revised and/or the competition may be conducted in an online mode.

16. ACCOMMODATION & FOOD

- Accommodation shall be provided to the participating teams for the duration of the competition i.e. from 20th March 2024, 12:00 pm till 24th March, 2024, 11:00 am.
- Food will be provided from 21st March 2024 till 24th March 2024. Only breakfast shall be provided on 24th March, 2024
- All facilities shall be provided only to the registered members of a team and no additional members, parents, observers, coaches or faculty advisors shall be accommodated.

17. EXCHANGE OF WRITTEN SUBMISSION

- The exchange of Written Submissions shall take place prior to the Oral Pleading Rounds.
- Teams are prohibited from making any marks on the opponent's Written Submissions thus exchanged. Teams are also prohibited from making any copies of the opponent's Written Submission, electronically or otherwise.
- The opponent's Written Submissions shall be returned to the Court clerks after the completion of each Round.

18. JURY OF APPEALS

 The Jury of Appeal is constituted to ensure transparency in the competition and accountability of the organizers, with respect to any dispute in the '4th Adamas National Moot Court Competition, 2024' on the spot.

- If a Team believes that the Rules of the Competition have been violated at any stage of the Competition, the Team shall, within half an hour after the completion of the round in which the alleged violation has occurred, register a complaint with the Jury of Appeal of the Competition at <u>solj.mootcourt@adamasuniversity.ac.in</u>.
- All the decisions and directions approved by the aforesaid committee shall be binding for all the teams participating in the competition.

19. COMPENDIUM

- Compendium is not mandatory but is highly encouraged.
- All relevant case laws and statutory material to be passed on to the Judges during the Oral Rounds may be submitted in the form of a Compendium 10 minutes prior to the commencement of the Rounds to the Court clerks.
- Participants are also permitted to pass on relevant material to the Judges, at their discretion, any time after the commencement of the Rounds and before its completion.
- Participants shall ensure that anonymity is not violated while passing on any material to the Judges. No mark, name, seal, symbol or logo of the institution/college/university shall be present. Participants must ensure that the same is rendered unrecognisable.
- All relevant case laws and statutory material (if any) to be passed on to the Judges during the Oral Rounds may be submitted in the form of a Compendium 10 minutes before the commencement of the Rounds to the Court clerks.
- Participants are also permitted to pass on relevant material to the Judges, at their discretion, any time after the commencement of the Rounds and before its completion.
- Participants shall ensure that anonymity is not violated while passing on any material to the Judges. No mark, name, seal, symbol or logo of the institution/college/university shall be present. Participants must ensure that the same is rendered unrecognisable.
