ABOUT CSL

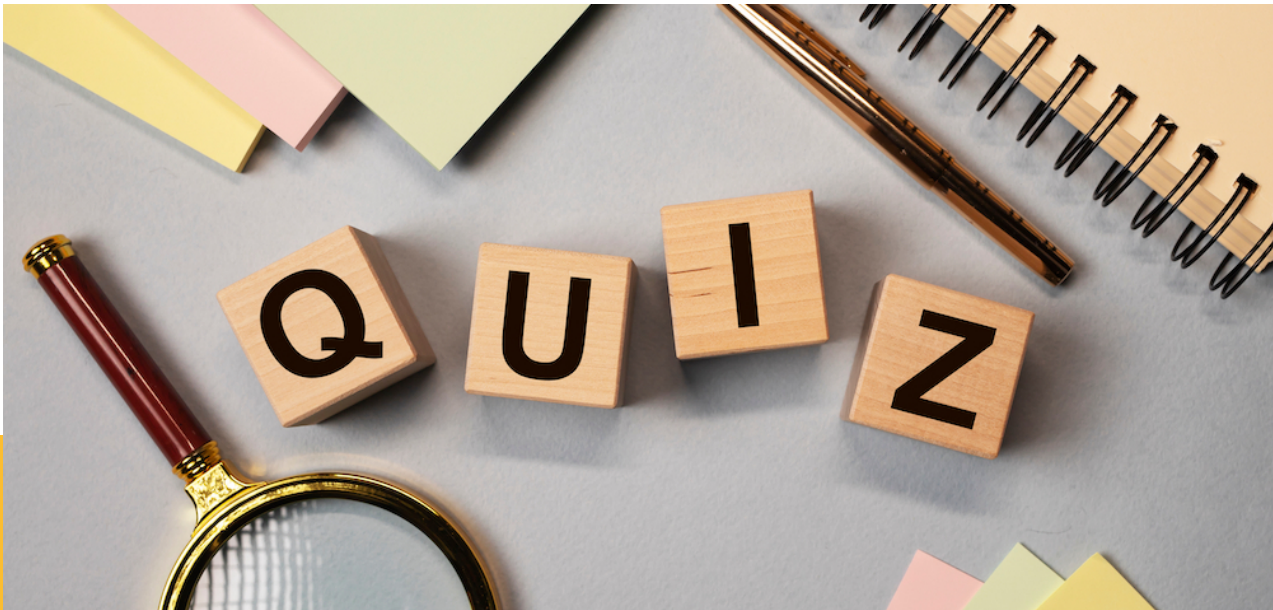
